

## BODYARMOR® T3 FALL FOOTBALL SWEEPSTAKES

### OFFICIAL RULES

#### NO PURCHASE NECESSARY

1. **SWEEPSTAKES DESCRIPTION:** The **BODYARMOR® T3 Fall Football Sweepstakes** (“**Sweepstakes**”) begins on 8/15/22 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 11/1/22 at 11:59:59 PM ET (the “**Sweepstakes Period**”). Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of BA Sports Nutrition, LLC, 17-20 Whitestone Expressway, Suite #401, Whitestone, NY 11357 (“**Sponsor**”), which shall be final and binding in all respects. The administration of the Sweepstakes will be conducted by TPG Rewards, Inc., 19790 West Dixie Hwy, Suite 808, Aventura, FL 33180 (“**Administrator**”).

2. **ELIGIBILITY:** Open to legal United States residents residing in the fifty (50) United States, District of Columbia and Puerto Rico who are twenty one (21) years of age or older. Employees, officers and directors of BA Sports Nutrition, LLC, Administrator, DraftKings, Inc. and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (collectively, the “**Sweepstakes Entities**”) and the immediate family members, and/or those living in the same household of each, are ineligible to enter the Sweepstakes or win a prize. There will be fifty-two (52) prize pools (each, a “**Prize Pool**” and collectively, the “**Prize Pools**”) for the Sweepstakes. The Prize Pools shall consist of the number of prizes per each participating state, the District of Columbia, and Puerto Rico. All requested information on the entry form at the Website must be completed to enter and to be eligible for a chance to win. Incomplete entries will be disqualified. All entries must be received by the end of the Sweepstakes Period in order to participate. The Website’s database clock will be the official timekeeper for online entries in this Sweepstakes.

The potential prize winners will receive their prize by mail, shipped to their address of residence which was collected at the time of entry. Sponsor shall have no liability for any winner prize that is lost, intercepted or not received by a potential winner for any reason.
